#### **Commitment to achieving Net Zero**

L & L Braines are committed to working towards achieving Net Zero by 2050, ensuring that as a business we strive to reduce our carbon footprint by 70% by 2040.

Our Carbon Reduction Plan has the full backing of Senior Management. Compliance with the systems and procedures is mandatory to all employees. This policy and any associated procedures are approved and endorsed by the Managing Director and will be reviewed every 6 months.

L & L Braines will ensure it operates within all environmental, legal and other requirements as imposed by EU and UK law and best practice.

Baseline emissions are a record of the greenhouse gases that have been produced in the past and were produced prior to the introduction of any strategies to reduce emissions. Baseline emissions are the reference point against which emissions reduction can be measured.

#### Additional Details relating to the Baseline Emissions calculations.

L & L Braines have used 2023 as their baseline year to represent our carbon footprint. The 2023 baseline emissions cover scope 1, scope 2 & scope 3 emissions. Prior to 2023, there was no available data for scope 3 emissions. However, please note our Scope 1 and 2 figures are slightly different from our previous plan as we have worked to improve the quality of our data.



# **Emissions reduction targets**

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We have adopted the following carbon reduction targets:

- carbon emissions to decrease to 65 tCO<sub>2</sub>e by 2030. This is a reduction of 35%.
- A further reduction of 50% by 2040, aiming to become net-zero by 2050

- Upgraded all vehicles in our fleet to Euro 6

#### Waste Management

- All redundant items are recycled with aim to zero landfill
- Furniture items are donated to various charities and reused, avoiding landfill

In the future we hope to implement further measures such as:

- Introduce plug-in hybrid vehicles
- Upgrade all electrical lighting to LED throughout premises
- Sensor lighting throughout warehouses
- Contribute to sustainable development programmes
